This document is applicable to sodium tripolyphosphate used for treatment of water intended for human consumption. It describes the characteristics and specifies the requirements and the corresponding test methods for sodium tripolyphosphate. It gives information on its use in water treatment.

#### 3.2 Commercial form

The sodium tripolyphosphate is available in a number of different forms (see 3.3.1).

Different commercial forms, solids or dissolved in water are possible. All concentrations mentioned refer to the active matter and shall be calculated accordingly.

NOTE Sodium tripolyphosphate can be a component of mixtures sold for water treatment purposes.

#### 3.3 Physical properties

##### 3.3.1 Appearance

Solid: the product is a white powder or granules.

Liquid: the product is a clear solution.

### 3.3.2 Density

Solid: the bulk density of the product varies from 100 g/dm<sup>3</sup> to 300 g/dm<sup>3</sup>.

Liquid: the density of solution is 1,046 g/ml for a product concentration of 50 g/l at 20 °C.

### 3.3.3 Solubility in water

The solubility in water is approximately 150 g/l at 25 °C.

For the solid product 600 °C.

The solutions of sodium tripolyphosphate have alkaline reactions.
